Where appropriate, through TFG Asset Management, Tetragon seeks to own all, or a portion, of asset management companies with which it invests in order to enhance the returns achieved on its capital. Tetragon's investment objective is to generate distributable income and capital appreciation. It aims to provide stable returns to investors across various credit, equity, interest rate, inflation and real estate cycles.





Third Quarter 2018 Review


- Tetragon's NAV: NAV increased by \$46.1 million during Q3 2018, driven by +\$57.9 million of net income, partially offset by dividends of -\$16.4 million and +\$4.6 million of scrip dividends. The net income comprises +\$79.9 million of investment income and gains, -\$10.5 million of operating expenses and management fees, -\$10.6 million of performance fees and -\$0.9 million of interest expense.
- Largest performance drivers: Main performance drivers during the quarter were (1) investments in private equity stakes in asset management companies (+\$36.8 million), where most of the valuation gains were attributable to Equitix, primarily related to the impact on its business model of the acquisition of John Laing Infrastructure Fund; and (2) bank loan investments (+\$22.0 million), mainly due to gains from certain corporate actions (including calls, refinances or resets) and LIBOR. Detractors during the quarter were: (1) Tetragon's private equity stake in asset management company Polygon (-\$2.4 million), and (2) quantitative strategy investments (-\$1.4 million).
- Additions, disposals, and receipts: Tetragon invested \$67.7 million during the quarter, primarily in the GreenOak funds and the "other equities" asset class. Tetragon received distributions of \$70.2 million, including \$31.1 million from other equities and \$28.1 million from bank loans.
- TFG Asset Management: Assets under management for TFG Asset Management were \$25.9 billion at 30 September 2018, vs. \$25.6 billion at 30 June 2018. Headcount was approximately 350 at 30 September 2018.


NAV Per Share Total Return and Share Price Total Return Since IPO⁽⁷⁾
