

Tetragon is a closed-ended investment company that invests in a broad range of assets, including public and private equities and credit (including distressed securities and structured credit), convertible bonds, real estate, venture capital, infrastructure, bank loans and TFG Asset Management, a diversified alternative asset management business. Where appropriate, through TFG Asset Management, Tetragon seeks to own all, or a portion, of asset management companies with which it invests in order to enhance the returns achieved on its capital. Tetragon's investment objective is to generate distributable income and capital appreciation. It aims to provide stable returns to investors across various credit, equity, interest rate, inflation and real estate cycles.

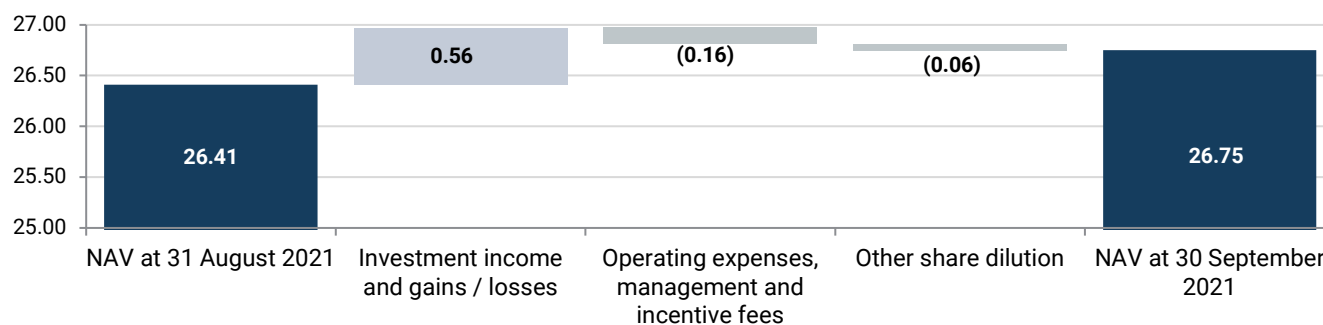

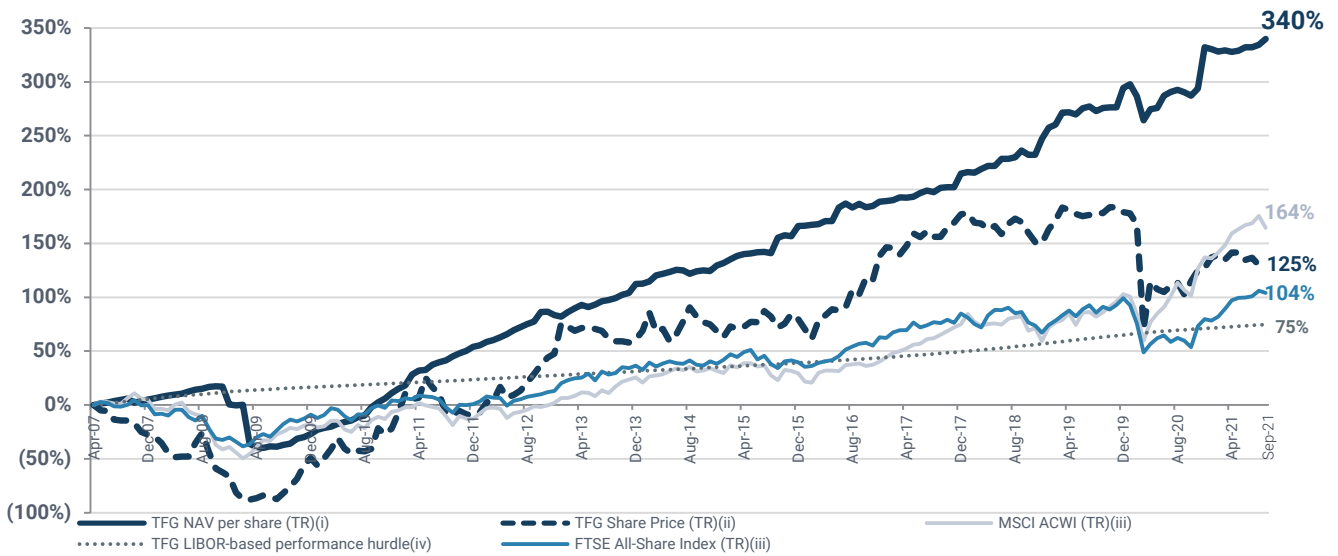
(ii) Assets characterised as "other equities & credit" consist of investment assets held directly on the balance sheet. For certain contracts for difference (CFD), gross value or required margin is used. Under IFRS, these CFDs are held at fair value which is the unrealised gain or loss at the reporting date. Payments and receipts on the same investment have been netted off against each other.

(iii) Net cash consists of: (1) cash held directly by Tetragon, (2) excess margin held by brokers associated with assets held directly by Tetragon, and (3) cash held in certain designated accounts related to Tetragon's investments, some of which may only be used for designated purposes without incurring significant tax and transfer costs, and (4) adjusted for all other assets and liabilities at the reporting date including any drawn amounts on the revolving credit facility.

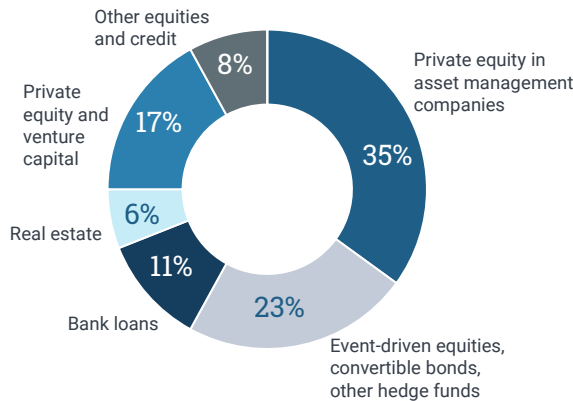
## Third Quarter 2021 Review

- ◆ **Tetragon's NAV:** NAV increased by \$53.0 million during the third quarter of 2021, driven by net income of +\$60.8 million, offset by -\$7.8 million of dividends and other capital items. The net income comprises +\$88.1 million of investment income and gains, -\$11.4 million of operating expenses and management fees, -\$14.4 million of incentive fees and -\$1.5 million of interest expense.
- ◆ **Largest performance drivers:** During the third quarter, all asset class segments had positive returns with the exception of investments in "other equities and credit". Positive contributions primarily came from the private equity in asset management companies segment, known collectively as TFG Asset Management, in particular: (1) the BentallGreenOak investment (+\$31.6 million), due to strong performance, in terms of AUM and projected EBITDA growth, and (2) LCM (+\$17.8 million) due to an increase in AUM as a result of successfully launching two new CLOs LCM 33 (\$509.2 million) and LCM 34 (\$509.8 million), and an increase in the P/AUM multiples observed in the market. Another meaningful contributor for the quarter was Tetragon's investments in the Polygon European Equity Opportunity Fund Absolute Return and Long Bias share classes (+\$18.7 million). Primary detractors during the quarter were (1) the investments included in 'other equities' (-\$12.8 million); and (2) the investment in Hawke's Point funds and co-investments (-\$10.6 million), driven primarily due to the valuation impact of significant operating issues at one of the fund's Australian gold mines.
- ◆ **Additions, disposals, and receipts:** Tetragon made additional investments of \$82.4 million, including \$20.1 million into "other equities", \$15.9 million into investments in direct private equity and venture capital, and \$10.6 million via Banyan Square funds. During the third quarter, Tetragon made its first litigation finance investment of \$10.6 million via a commitment to a fund managed by Contingency Capital. Aggregate disposals and receipts from investments were \$35.9 million which included \$18.2 million of cash generated by bank loans.
- ◆ **Cash:** Tetragon's net cash balance, which is cash adjusted for known accruals and liabilities (short and long-dated), was -\$175.6 million as at 30 September 2021. Tetragon has in place a 10-year \$250 million revolving credit facility. As at 30 September 2021, \$150 million of this facility was drawn and this liability has been incorporated into the net cash balance calculation.
- ◆ **TFG Asset Management:** AUM for TFG Asset Management was \$34.9 billion at 30 September 2021.<sup>(6)</sup> Headcount was approximately 460 at the end of the quarter (excluding BentallGreenOak).
- ◆ **Dividend:** As set forth in a separate Tetragon announcement, the Board of Directors declared a dividend of \$0.10 per share in respect of the third quarter of 2021.

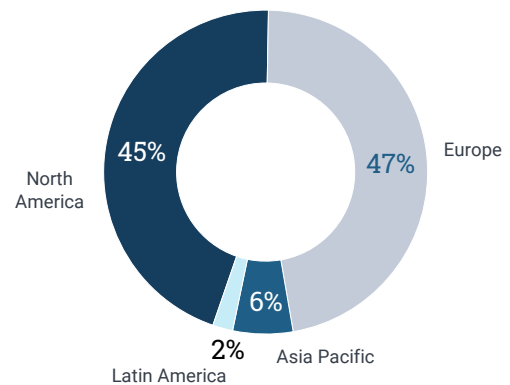
NAV Per Share Total Return and Share Price Total Return Since IPO<sup>(7)</sup>

NAV Total Return is determined in accordance with the "NAV total return performance" calculation as set forth on the Association of Investment Companies (AIC) website. Tetragon's NAV Total Return is determined for any period by calculating, as a percentage return on the Fully Diluted NAV Per Share (NAV Per Share) at the start of such period, (i) the change in NAV Per Share over such period, plus (ii) the aggregate amount of any dividends per share paid during such period, with any dividend deemed reinvested at the NAV Per Share at the month end date closest to the applicable ex-dividend date (i.e., so that the amount of any dividend is increased or decreased by the same percentage increase or decrease in NAV Per Share from such ex-dividend date through to the end of the applicable period). NAV Per Share is calculated as Net Assets divided by Fully Diluted Shares Outstanding. Source: Tetragon.
- (2) Tetragon seeks to deliver 10-15% Return on Equity (RoE) per annum to shareholders. Tetragon's returns will most likely fluctuate with LIBOR. LIBOR directly flows through some of Tetragon's investments and, as it can be seen as the risk-free short-term rate, it should affect all of Tetragon's investments. In high-LIBOR environments, Tetragon should achieve higher sustainable returns; in low-LIBOR environments, Tetragon should achieve lower sustainable returns. In the current environment characterised by continued and sustained low risk-free interest rates, reduced sustainable returns across Tetragon's investments, including outside of Tetragon's target return rate, are to be expected. The "Annual Average Since IPO" figure includes the current year.
- (3) The dividend yield represents the last four quarterly dividends divided by the TFG NA share price at the date of this Monthly Factsheet. The 5-year Compound Annual Growth Rate (CAGR) figure is at 30 September 2021. Each of the foregoing includes in its calculation the latest declared dividend.
