Tetragon is a closed-ended investment company that invests in a broad range of assets, including public and private equities and credit (including distressed securities and structured credit), convertible bonds, real estate, venture capital, infrastructure, bank loans and TFG Asset Management, a diversified alternative asset management business. Where appropriate, through TFG Asset Management, Tetragon seeks to own all, or a portion, of asset management companies with which it invests in order to enhance the returns achieved on its capital. Tetragon's investment objective is to generate distributable income and capital appreciation. It aims to provide stable returns to investors across various credit, equity, interest rate, inflation and real estate cycles.



First Quarter 2020 Review

- ◆ Tetragon's NAV: NAV decreased by \$203.1 million during the first quarter, driven by net income of -\$178.9 million, net dividends of -\$12.2 million and repurchase of tax shares from TFG Asset Management of -\$12.0 million. The net income comprises -\$166.6 million of investment income and gains/losses, -\$10.3 million of operating expenses and management fees, and -\$2.0 million of interest expense.
- ◆ Largest performance drivers: Amid a particularly challenging market backdrop during the first quarter, all asset classes had negative performance, although there were some positives in underlying investments. The largest detractors were: (1) the investment in the Absolute Return class of the Polygon European Equity Opportunity Fund in the event-driven equities category (-\$41.9 million), where most losses in the event-driven equities portfolio are marked to market; (2) other equities (-\$40.8 million), where the losses are primarily marked to market; and (3) the investment in Hawke's Point Fund 1 in the private equities and venture capital bucket (-\$29.6 million). The strongest performers were (1) the investment in Equitix in the private equity in asset management companies segment, (+\$14.4 million), driven by AUM growth and performance, partially offset by an increased discount rate used in the DCF model utilised by TFG Asset Management's independent valuation agent; (2) the investment in the BentallGreenOak Europe funds and co-investments (+\$11.4 million) which was driven by realised gains following the disposal of assets in Spain and Italy; and (3) investments in direct private equity (+\$6.4 million).
- ◆ Additions, disposals, and receipts: Tetragon made additional investments of \$70.1 million, including a further \$30 million into the Polygon event-driven equity funds, and had disposals and receipts of -\$137.2 million during the first quarter. Of note, TFG Asset Management received \$17.4 million from its Equitix investment as repayment of loan notes. Bank loans generated cash of \$15.4 million and Tetragon received \$34.7 million of distributions from real estate investments in BentallGreenOak funds.
- ◆ TFG Asset Management: AUM for TFG Asset Management was \$27.0 billion at 31 March 2020. (6) Headcount was approximately 330 at the end of the first quarter (excluding BentallGreenOak).
- ◆ Dividend and Intention to Conduct Tender Offer: As set forth in a separate Tetragon announcement, the Board of Directors declared a dividend of \$0.10 per share in respect of the first quarter of 2020. In light of market conditions, Tetragon has determined to modify its Dividend Policy (Tetragon's Dividend and Capital Return Policy is available at https://www.tetragoninv.com/investors/dividends/dividend-policy). Tetragon also announced its intention to conduct a tender offer for a number of Tetragon non-voting shares with a maximum value of up to \$25 million.
- ◆ Investor Day and Investor Call: Regrettably, Tetragon's Investor Day that had been scheduled for 29 April has had to be cancelled due to the ongoing coronavirus restrictions in place. Instead, the manager is hosting a call for shareholders reviewing first quarter results, giving a business update and answering questions from investors. The call will be held on Thursday, 30 April 2020 at 3:30 pm BST (10:30 am EDST). A recording will be available on Tetragon's website after the call.


